

Website Terms and Privacy Policy – Wardrobes Online

Introduction

These terms set out the basis upon which you may use this website, information about the copyright in this website and our privacy policy, which describes what we do with personal information we collect from you and the ways in which we may collect the information. We do not sell, rent or trade your personal information to third parties for marketing purposes.

Our website may contain links to third party websites. We are not responsible for the privacy policies of any third party websites. We recommend that you review the privacy policy of each website you visit.

Collection of Personal Information

We may collect information from you through your use of our website, when you request information from us or engage our services.

- By using any of our services, including our website, and providing us with any personal information, you are consenting to the use of your personal information as set out in this policy. Please do not send us any personal information if you do not want it to be used in this way.
- A number of areas on our website invite you to provide us with personal information. For example your names and email address. The purpose of the information collection is apparent at the point that you provide your personal information.
- Information collected includes the IP address of your machine when connected to the Internet; the domain name from which you are accessing the Internet; the operating system and the browser your computer uses and any search engine you are using; the date and time you are visiting; the URLs of the pages you visit, as well as any other information you may explicitly provide in the course of accessing the website such as your name, gender, email address and other personal details such as telephone number.
- The Wardrobes Online website uses server logs and web analytic tools (such as “cookies”). Cookies are small text files that are downloaded to your device by websites you visit. When you use this website these tools collect information such as what browser and operating system you use, the internet protocol address of the device you have used to access the website, search terms, your location and what content you view when visiting our website. Cookies do not give us access to your computer or any information about you other than the data you choose to share with us.
- You can set your browser to block all cookies, including cookies associated with our website, or to indicate when a cookie is being set by us. If you do set your browser to reject cookies you may not be able to access all the features of the website.

By providing your personal information to Wardrobes Online in this way, including by completing on-line forms and email, you agree to the collection of that information in accordance with this privacy policy.

Use of information

- We will only use personal information that you provide to us for the purposes for which you supplied it or, in exceptional situations, for other reasons permitted under the Privacy Act 1993.
- While it is unlikely, we may be required to disclose your information to comply with legal or regulatory requirements. We will use reasonable endeavours to notify you before we do this, unless we are legally restricted from doing so.
- We will take reasonable steps to ensure that the personal information about you we collect, use or disclose is accurate, complete, up to date and stored in a secure environment protected from unauthorised access, use, modification or disclosure.

Social Media

To customise your user experience on our website we may provide you with the opportunity to connect, access and/or interact with third-party social networking services, such as Facebook, Google+ and Instagram. If you connect to these third-party social networking services, including to participate in one of our promotional campaigns, you are authorising Wardrobes Online to access and use certain information from your social network profile. You can opt-out of authorising Wardrobes Online from collecting or accessing your information when you are not using the application and you can cancel this service at any time by deleting the application from your social network account.

We will provide you with access to any personal information we hold about you. If it is wrong please ask us to correct it. To ask for access and correction, see our contact details.
